

Spectra Home Apple TV Spring Campaign

Terms & Conditions

1. MTC will be running a Fiber-only promotion from 12 August 2024 until the 10th of November 2024 both days included, while stock lasts. Where new and existing Spectra Home subscribers will receive an Apple TV stream device for free.
2. The promotion is applicable to both new and existing customers where MTC Fiber is available.
3. For customers to qualify for the free Apple TV streaming device, they should sign up for the below-mentioned Spectra packages:

4. Existing customers migrating technologies from Microwave (PTMP) to FTTH on 50 Mbps or 75 Mbps qualify.
5. Free installation is applicable on 24- and 36-Months Spectra Packages.
6. The Apple TV streaming device will be provided once the subscriber's account is activated for billing.
7. The customer must provide a valid email address and cellphone number for the collection of the Apple TV streaming device at their nearest Retail Store if not delivered during onboarding.
8. All subscribers will get 3 months of the following services:
 - a. Apple TV+ subscription
 - b. Fitness Plus
 - c. Arcade
 - d. The customer shall be charged a monthly fee after the free access provided by Apple for the subscription, exclusive of the monthly internet fee.
9. The promotion is only available for residential customers and not on business packages, and only where MTC has fiber available as a service. Coverage can be verified via our customer service.
10. The subscriber agrees to be bound by these Terms and Conditions by subscribing to this service during the promotion.
